# Scope and content

This collection contains correspondences, documents, photos, and other types of material related to Joseph and Effie Gibson and their descendants. Most of the correspondence in this collection concerns the oldest son of Joseph and Effie Gibson named Joe Gibson, who was a pilot with the Royal Canadian Air Force during the Second World War who went missing during a flight. Many photos of him and his crewmates, his letters home from overseas, as well as his schoolwork and notes from leaning how to fly an aircraft, are also included in this collection. Several items which concern the affairs of John Gibson, Joe Gibson's younger brother, can be found in this collection. These include correspondences and legal documents related to the estate of Charlotte Gibson, his sister, as well as an agreement between John Gibson and the Canada Railroad Company concerning interest and his land. Most of the personal items and published material in this collection belonged to John Gibson as well, these include publications related to his position as a volunteer firefighter, reports of organizations he belonged to, maps of the Town of St. Andrews, notes related to his work as a stonemason, and other items.

#### Scope and content:

This series contains correspondence addressed to various members of the Gibson Family of St. Andrews, New Brunswick. Most of the letters concern Joe Gibson, the son of Effie Gibson and Joseph Gibson, a pilot with the Royal Canadian Air Force who fought German U-Boats in the Bay of Biscay during the Second World War. On September 2 1943 Joe Gibson went missing during a flight and was presumed dead, so most of the letters are from friends of the Gibson family or of Joe Gibson writing to express their sympathy. This series also contains Joe Gibson's letters from overseas, as well as more recent letters addressed to John Gibson concerning the affairs of Charlotte Gibson after her death on March 9 2001.

### Scope and content:

This subseries contains letters addressed to Effie Gibson of St. Andrews, New Brunswick. Nearly all of the letters in this subseries concern her son Joe Gibson, a pilot with the Royal Canadian Air Force during the Second World War. During his service Joe Gibson received the Distinguished Flying Cross medal, so there are a few letters expressing congratulations for this feat. Most of the letters in this subseries are from friends of the Gibson family or of Joe Gibson, expressing their sympathy after he went missing during a flight and was presumed dead. There are many letters from Kathleen Waters from Vancouver, British Columbia, who was the mother of a member of Joe Gibson's crew named Ken Waters. These letters often contain details of daily life in Canada during the Second World War, as well as first-hand accounts of notable events. These include an account of British prisoners of war from Japan arriving in Vancouver, and the stories they told about being in the Nagasaki Shipyards when the United States of America dropped the second atomic bomb on Japan, and an account of the Greenhill Park Explosion, a disaster involving a ship with improperly stored ammunition in Vancouver's harbour. There are also correspondences with the Tierney family of Nova Scotia concerning the loss of Ralph Tierney, another member of Joe Gibson's crew, and some correspondences with the Department of National Defense and the R. C. A. F. concerning Joe Gibson's estate and legal affairs.

Her letters often concern life in Canada during the Second World War and personal events.
